### **1137. MINUTES OF PREVIOUS MEETING.**

The minutes of the previous meeting held on 8 March 2018 were approved and signed by the Chairman.

### **1138. DECLARATIONS OF INTEREST.**

No declarations were made.

### **1139. ELECTION OF CHAIRMAN.**

In the absence of other councillors being willing to be nominated for the office of Chairman, it was agreed to dispense with the provisions of Standing Order 2.3, relating to the period of office of the chairman. It was therefore agreed that Councillor Allan Kerr be elected as chairman for the year 2018/2019.

### **1140. ELECTION OF VICE CHAIRMAN.**

Councillor Bill Harrison, nominated by Councillor Allan Kerr, seconded by Councillor Helen Fletcher and in the absence of other nominations was elected Vice Chairman for the year 2018/2019.

### **1141. ANNUAL PARISH MEETING.**

The agenda for the Annual Village meeting was agreed and the date set for 17 May 2018 in the Village Hall at 7:00 p.m.

### **1142. MINERALS LOCAL PLAN.**

The draft Minerals Local Plan was scheduled for consideration by Nottinghamshire County Council on 17 May 2018. A planning application for the Barton in Fabis site is still outstanding.

1143. **ANNUAL GOVERNANCE STATEMENT.**

This was circulated and approval given for the Chairman to sign on behalf of the Council.

1144. **FINANCE.**

The clerk circulated a statement setting out payments and receipts to 31 March 2018. It was agreed that the report be noted.

The draft accounts for the year 2017/2018, subject to audit were approved. Bank balances in the current account with Cooperative Bank of £1,638.46, less unpresented cheques amounting to £680.00 and the balance in the savings account with the Skipton Building Society £16,530.75. Total payments in the year amounted to £3,883.62 and receipts of £4,424.84.

A cheque for £33.00 was approved for payment.

1145. **PLANNING APPLICATION OLD FARMHOUSE 27 RECTORY PLACE, 18/00774/LBC**

The application was considered and it was agreed not to raise any objections.

1146. **PLANNING APPLICATION THE BARN, GRANGE FARM CHESTNUT LANE 18/00376/FUL.**

The application was considered and it was agreed that the application not be supported.

It was reported that the planning application for The Top Yard Farm Rectory Place Barton In Fabis Nottinghamshire NG11 0AJ , 17/03028/FUL considered by at the meeting on 18 January 2018, minute 1117, had been approved with conditions.
