#### 1224. DECLARATIONS OF INTEREST.

No declarations were made.

### **1225. MINUTES**

The minutes of the Extra Ordinary meetings held on 1 August 2019 and 22 August 2019 and were approved and signed by the Chairman.

# 1226. **DISTRICT REPORT**

No meetings of Rushcliffe Borough Council had taken place during August. The Rushcliffe Local Plan has yet to be reported on by the Inspector. Once it has been received, a special meeting of Rushcliffe Borough Council will be convened to consider it.

## 1227. MINERALS LOCAL PLAN

A third Regulation 25 request has been sent to the applicant for the proposed sand and gravel quarry. A response awaited from the developer. Consultation on the soundness of the Minerals Local Plan has commenced and this closes on 11 October 2019. A meeting of Village residents will be held to sound out views of residents. Legal advice will be sought to inform the Parish Council's response.

#### 1228. FAIRHAM PASTURES

The developers for this site are proposing an exhibition in the Barton Village Hall on 25 September that will be open to Village residents. The developer and officers from Rushcliffe Borough Council will be in attendance.

# 1229. TOP OF NEW ROAD

Three options are open for consideration.

- 1. Bench and finger post with tree planting.
- 2. Bench, finger post, tree planting and welcome sign.

3. Mowing and regular maintenance of the site.

The preference was for option one, with the planting of wild flowers.

#### 1230. **FINANCE**

The Clerk circulated a statement of payments and receipts up to 31 August 2019, the contents of which were noted.

Cheques totalling £,669.69 were approved for payment.

## 1231. CLERK'S ANNOUNCEMENTS

The Parish Council has been invited to membership of the Fairham Growth Board, the first meeting of which will take place on 9 October 2019, this will include representatives of Gotham Parish Council, Thrumpton Parish meeting, the developers and officers from Rushcliffe Borough Council.

Barton Lane Thrumpton will be closed to traffic from 30 September 2019 for two weeks to allow road works to be carried out.
