1255. **DECLARATIONS OF INTEREST.**

1256. **MINUTES**

1257. BARTON IN FABIS PARISH WEBSITE

Bryn Baxendale was welcomed to the meeting and he provided a presentation on the development of the Barton in Fabis Village website, which would provide a section for use by the Parish Council. Input was requested from the Parish Council and it was anticipated that it would be available for use in the near future.

1258. MINERALS LOCAL PLAN.

An inspector has been appointed and the public enquiry was scheduled to commence on 28 April 2020 and last approximately one week. At this stage the Barton site was identified as one of the "Matters and issues" to be considered by the enquiry and approval was given for further legal advice to be sought up to a level of £500.

1259. FAIRHAM PASTURES

There was nothing further to add on the planning applications. Clarification was to be sought on the long term source of heating for the properties. It was also agreed to establish whether the tree planting programme could commence in advance of the construction stage.

1260. TOP OF NEW ROAD

The finger post has now been ordered and the area marked out for planting the wild flowers when the weather improves.

A copy of the latest crime figures received from Nottinghamshire Police was circulated, the contents of which were noted.

1262. PLANNING APPLICATION

A planning application, Land Southeast and Northwest of A453 Known as Nottingham Gateway was considered and it was agreed to delegate the response to the Chairman.
