1357. FAIRHAM DEVELOPMENT.

Issues remain over access to part of the site and action is awaited from Nottingham City Council to resolve this.

1358. PLANNING APPLICATION MILL HILL SAND AND GRAVEL QUARRY.

The final Section 25 submission has now been completed and the formal period for consultation will end on 10 September 2021.. It was agreed to establish a budget of £3,000 to cover the Parish Council's costs to enable it to respond. A meeting of Village residents and other interested parties will be held during August to gauge the nature of the response.

1360. OLIVER'S YARD UPDATE.

Enforcement notices have not been served as there a number of technical issues to be resolved.

1361. PLANNING APPLICATION: TRAVELLLERS PITCHES.

It was agreed to support the application, subject to the site being managed by a registered site manager. The approval should be for a maximum of four pitches and the final scheme must meet the government's code of code practice for the operation of travellers' sites. Permanent fencing should surround the site to prevent unauthorised access.

1362. PLANNING APPLICATION RESIDENTIAL DEVELOPMENT FAIRHAM.

The application has been received for the first phase of residential developmet. It was resolved to await the resolution of highways issues before commentating. The commentary from the Master Planners is also awaited to establish how this fits in with the overall vision for the Fairham development.

1363. CONSULTATION RUSHCLIFFE WARD BOUNDARIES.

Consultation is in hand to review the ward boundaries for Rushcliffe Borough Council. It was agreed to support the views previously expressed by the ward councillor for Gotham.

1364. OLIVER'S YARD.

It was anticipated that the site would be subject to a visit from Rushcliffe Panning's enforcement team to determine whether the new structure on the site required a planning application.

1365. CHESTNUT LANE: KERBS.

Nottinghamshire County Council have come up with a solution to resurface the triangle on Chestnut Lane and will be included in the plan for highways work.

1366. VILLAGE WELCOME PACK.

Work is in progress to update the Welcome Pack for new residents to Barton..
